NAISO in the past has requested similar exchanges but nothing format has been done yet.
A Proposal for a new journal "Transactions on Computational Biology and Bioinformatics" was received in June 2003, from the Computer Society with co-sponsorship from EMBS and ACM. At the June TAB meeting the proposal was discussed and NNS was approved as a cosponsor to the journal. The MoU will be signed as soon as approval is received.

As a point of order, David Fogel advised for the record that the Pubs committee and Editors approved this proposal in their committee meeting on 19 July 2003.

Micheli- Tzanakou pointed out that each society be allowed 1 representative (equal representation by all) in the search committee for an editor in Chief, although the percentages for sponsorship and for associate editors are not equal for all parties involved.

## Work on Web site

There is a need to have full time support in keeping the NNS web site current. In addition, the site should have external links (for example, the European and Japanese NNS site). The supporting person could be a student or contractor.

Micheli-Tzanakou led a review of the Letters included in the AdCom Meeting book. Letter \#1 from Mary Ann DeWald re: Letter of Invitation to people in order to obtain a visa.
It was discussed that the use the term "Letter of Invitation" should be avoided because we may be making ourselves liable for the attendees conduct while in the United States. Mohamed El Sharkawi pointed out that this term also has financial implications due to the INS insurance requirements. It was suggested that the subject of the letter could reference the individual is a presenter but not as a letter of invitation.

## Past-President Report - Piero Bonissone

IEEE NNS Transitional Government - Results from random assignment of Society
Representatives for 2004 and 2005.

- In 2002 we defined a random process that associated the first twelve numbers drawn on January 2nd 2003 by the New York Lottery (known as "PICK 10") with the twelve exsponsoring societies of the IEEE NNS.
- The process, which was agreed upon by each of the twelve presidents of our exsponsoring societies, was used to determine the six societies who will appoint an AdCom representative in 2004 and the other six who will appoint a representative in 2005.

Constitution and Bylaws (Proposed Changes) - Election of Vice-President-Elect, Finance (on odd-years) instead of Vice-President, Finance (on even-years)

## Proposed Amendment to NNS Bylaws:

Modification of term of office and election procedures for VP for Finance
Rationale: The performance of the Vice President for Finance is key to the continued success and development of the Society. Experience with IEEE finances and accounting methods are important to assure proper discharge of the duties specified in the NNS C\&BL.

Recent NNC and NNS Bylaws have recognized its importance by allowing re-election to this executive position.

Early election of a Vice President for Finance so as to permit his/her collaboration as officer elect of the Society is intended to promote continuity in the handling of Society finances while assuring adequate experience in the discharge of his duties as Vice President, Finances

Outline of Proposed Changes

- VP Finance is elected on odd-years
- If approved, it will be elected on odd years
- It will start term next odd-year.
- Invited to ExCom at the President discretion:
- Not an officer
- Non-voting
- First election: 2003
- Trains during 2004, and assists VP Finances

## Concept of TF

- The TCs are "Standing Committees."

- The TC conducts its technical activities via Task Forces (TF) or Working Groups (WG).
- A TF committee deals with a specific narrow assignment which, when completed, will terminate the committee.
- A WG is similar to the TF, but
- Its assignment is wider in scope
- Its duration is longer


## TF \& WG

- TC may find it necessary to organize one or more Task Forces comprised of members (and when necessary, nonmembers) of the NNS.
- The Task Force is established by the Chair of the Technical Committee to investigate, evaluate and recommend action to the TC on special matters brought before it.
- The chair of the task force is selected by the TC chair.
- The task force name will normally include the subject area for which it was created or assigned.
- Assist TC Chairs in recognizing and nominating outstanding technical leaders for awards
- Encourage TCs with common technical interests and overlapping scopes to sponsor joint technical activities, such as workshops, symposia, and newsletters.

## Objective

- The goal of the NNS Distinguished Lecturer Program is to serve the needs of the members of the NNS Society, in particular those engineers working in industry and government, to enhance their professional vitality by keeping them informed of the latest research advances and their practical applications. A request for sponsorship of a lecture by one of the NNS Distinguished Lecturers must be made by a NNS Chapter Chair, and speakers should tailor their talks to serve the above purpose. Chapters are strongly encouraged to make use of this program.
- The NNS Distinguished Lecturer Program is not intended to provide speakers for conferences or for university seminars.)


## Nominations

- NNS Dis tinguished Lecturers are nominated by Chapter Chairs or by the DLP committee and serve for a term of two years.


## Appointments

- NNS Distinguished Lecturers are submitted by the NNS DLP committee for approval and are appointed by the NNS Executive Committee with the consent of the NNS Administrative Committee.


## Reappointments

- Distinguished Lecturers may be reappointed indefinitely but must deliver at least one lecture in their previous period of appointment. The latter requirement may be waived by the NNS Administrative Committee.


## Eligibility

- NNS Distinguished Lecturers should be NNS members in good standing who have advanced to Fellow grade. This requirement may be waived by the NNS President on special cases.


## Lectures

- Upon appointment, NNS Distinguished Lecturers should provide the DLP Chair with contact information and titles of their lectures. Within a period of 90 days after their appointment, Distinguished Lecturers should also provide electronic versions of their presentation material for posting on the NNS WWW site.


## Steps for organizing a Distinguished Lecturer Visit

7.1 Based on the interests of the members, the Chapter Chair chooses a topic and lecture from the list of current DLP lecturers and topics. The chair should contact the lecturer directly, copying the DLP Chair (address above), and work out preliminary details of the visit (chapter event, date, location, etc.).
7.2 This preliminary information, including an estimate of the cost, should be sent to the DLP Chair for approval. In general, the Lecturer's travel expenses will be reimbursed up to a maximum of $\$ 1500$. If expenses are incurred by the chapter, e.g., for hotel accommodations or for refreshments at the time of the lecture, they are paid to the chapter through IEEE. However, expenses to the lecturer will be paid first.
7.3 After the visit is approved by the DLP chair, the Chapter Chair should contact the lecturer to finalize arrangements. The lecture should be open to all members of IEEE. The chair is expected to publicize the event in the chapter or section newsletter and/or by special mailings to all members of the section. The event must be announced as "sponsored by the Neural Networks Society under its Distinguished Lecturer Program", and the lecturer should be mentioned as a NNS Distinguished Lecturer. If other IEEE societies or other organizations have offered to support this chapter activity, then proper acknowledgment of them should also be made.
7.4 Immediately following the event, the Chapter Chair should send a summary report to the DLP chair including information on the date and title of the lecture, a copy of the announcement/publicity, etc.
7.5 Reimbursement: The lecturer (and the chapter officers, if necessary) should retain receipts for all expenses, airline ticket stubs, etc. (See 7.2 above.) Following the event, the lecturer should complete the IEEE travel reimbursement form and send it by email or fax to the DLP chair. Hardcopy of the spreadsheet and original receipts should be mailed to the NNS Vice-president, Finance. If chapter officers require reimbursement, they should contact the DLP chair for instructions.
