#### Transactions on Neural Networks Report – Derong Liu

Reported on the status of T-NN highlighting the title and scope change to be effective January 2012. He presented the new cover design, and the schedule of

announcement for the remainder of 2011. He continued to report on the submission statistics, data for the PRAC and future plans for improvements.

## **Transactions on Fuzzy Systems Report – CT Lin**

Reported on highlights of TFS, including performance statistics: the first decision of over 74% papers is made within 90 days. The average time for submission to epublication over the last five quarters (up to Q4, 2010) is an 40.6 weeks. The administrative reject is high at 40% with the overall rejection rate at 66% in 2011. The journal remains in the top 10 for Impact factor in AI, EEE and IEE categories, and maintains it A rating in The Excellence in Research for Australia (ERA) Initiative. Lin also discussed special issue and the activity for Type-2 Fuzzy Set and System planned for 2013.

## Transactions on Evolutionary Computation Report - Garrison Greenwood

Reported on the special issues currently under way and those scheduled for future issues. He reported on the hig Impact Factor where the journal is ranked in the top 4 in the categories of Computer Science, Artificial Intelligence, and Theory and Methods journals. He also provided information on the page budget, publication queue and performance statistics of the journal.

## Transactions on Computational Intelligence and AI in Games Report – Simon Lucas

Reported on the statistics of the journal; timeliness; submission stats and current acceptance ratio; special issues that have been published and future special issues. He also presented the future plans for the journal including accepting short papers and letters and well as discussing the possibility of an Outstanding Paper award.

## Transactions on Autonomous Mental Development Report - Zhengyou Zhang

#### Editor, CI Magazine – KC Tan
